Legal Positivism— Whether a certain rule is a law, creating legal obligations to comply with it, all depends on its source Valid laws are simply rules that come from certain people (kings, city councils, etc), in accordance with certain procedures, that the society enforces A rule can be a genuine, valid law even though it is grossly unjust
